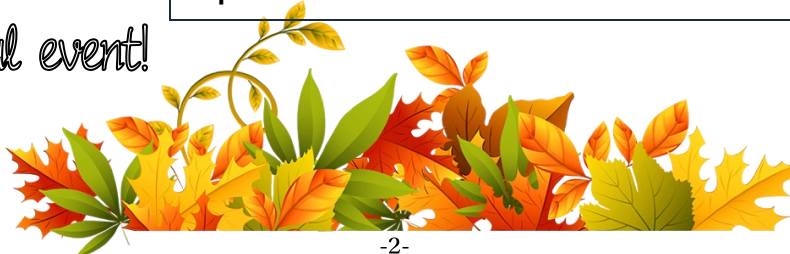

ARTICLE V . BOARD OF DIRECTORS

Section 3: SELECTION AND ELECTION OF DIRECTORS

Nominating Committee: At the regular September Board Meeting, the President shall appoint, subject to approval by the Board of Directors, a nominating committee consisting of the immediate past President as chairman and three members from the Board of Directors.

At the October board meeting, the nominating committee shall present to the Board of Directors, a slate of five (5) candidates to serve three-year terms, to replace the directors whose regular terms are expiring. Each candidate must be an active member in good standing and must have agreed to accept the responsibility of a directorship. No board member who has served two complete three-year terms is eligible for election for a third consecutive term. A period of one (1) year must elapse before eligibility is restored.

Publicity of Nomination: Upon receipt of the report of the nominating committee, the membership shall immediately be notified of the names of persons nominated as candidates for directors.

Nominations by Petition: Additional names of candidates for directors can be nominated by petition bearing the genuine signatures of at least 5% of the qualified members of the CHAMBER. Such petition shall be filed with the nominating committee within ten (10) days after notice has been given of the names of those nominated. The determination of the nominating committee as to the legality of the petition(s) shall be final.

Determination: If no petition is filed within the designated period, the nominations shall be closed and the nominated slate of five (5) candidates shall be declared elected by the Board of Directors at their regular November board meeting.

If a legal petition shall present additional candidates, the names of all candidates shall be arranged on a ballot in alphabetical order. Instructions will be to vote for five (5) candidates only. The Executive Vice-President shall mail this ballot to all active members at least 25 days before the regular December board meeting.

The ballots shall be marked in accordance with instructions printed on the ballot and returned to the CHAMBER office within ten (10) days. The Board of Directors shall at their regular December board meeting declare the five (5) candidates with the greatest number of votes, elected.

Judges: The President shall appoint, subject to the approval of the Board of Directors, at least 3, but not more than 5 judges who are not members of the Board of Directors or candidates for election. Such judges shall have complete supervision of the election, including the auditing of ballots. They shall report the results of the election to the Board of Directors.

ARTICLE VI . OFFICERS

Section 1: SELECTION AND ELECTION OF OFFICERS

The nominating committee shall also nominate a single slate of officers in the same manner as the directors. The officers to be nominated are President, Vice President, Secretary and Treasurer. All nominees shall be current members of the Board of Directors.

Said officers shall be elected to serve a one year term commencing on January 1, and ending on December 31, or until their successors have been qualified and duly elected.

The President and Vice President may succeed themselves in office for one additional one-year term if duly qualified and elected. The Treasurer and Secretary may succeed themselves in office for two additional one-year terms if duly qualified and elected.
